Greetings from Prof. Yehuda Neumark, IMPH Director

Dear IMPH Alumni,

We are in the final stretch of the 2017-2018 course, and another cohort will soon join your exclusive IMPH Alumni club! If I am not mistaken, we will pass the 100-country mark with the inclusion of four new countries - Antigua & Barbuda, Gambia, Serbia and Tonga!!

And with graduation just around the thesis/master paper corner, we have begun preparations for the 44th IMPH course and to welcome to Jerusalem the IMPH Class of 2018-2019!

These are exciting times for the IMPH program. The Hebrew University recently established an Authority for International Affairs, with an aim of promoting international scientific and academic collaborations, increasing the number of foreign students and scholars on our campuses, and increasing the number of HUJI students and researchers who study and work abroad. We are working closely with the new Authority and considering ways to expand the size of our annual cohort and perhaps broaden the scope of our curriculum, without impacting on the "intimate" environment of the program.

It is to unsettle their minds, widen their horizons, inflame their intellects, and teach them to think straight, if possible.

I think I can say with a fair degree of certainty that most of you gained more than just an education from the Braun School and the IMPH program, and that many of you look back to your days here with fondness, admiration, good memories and a sense of a worthwhile year despite the challenges of being away from home...

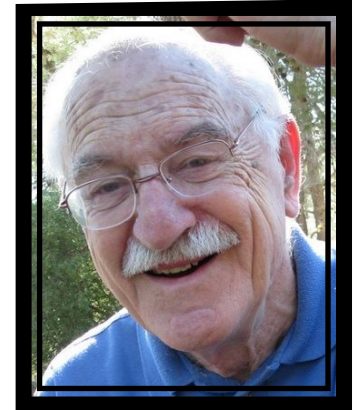

Dear Alumni,

The academic year is coming to a close as our students work on their Masters' papers or theses but alumni activities carry on! We welcome alumni (Joseph Akuamoah, Ghana; Moses Djimatey Barima, Ghana; Angela Benson, Liberia; Ulo Benson, Kenya; Lucas Esuh Esong, Cameroon; Mohamed Boie Jalloh, Sierra Leone; Evelyn Kimani, Kenya; Andrew Method, Tanzania and Emmanuel Ogum, Nigeria) in the last week of August for a TB workshop organised by Dr. Daniel Chemtob at the Ministry of Health, Jerusalem as a foundation course for a WHO- TB consultancy training program. We are very excited to welcome Dr. Norbert Rakiro home for this year's graduation as our Keynote Speaker! More on graduation 2018 in the next newsletter.

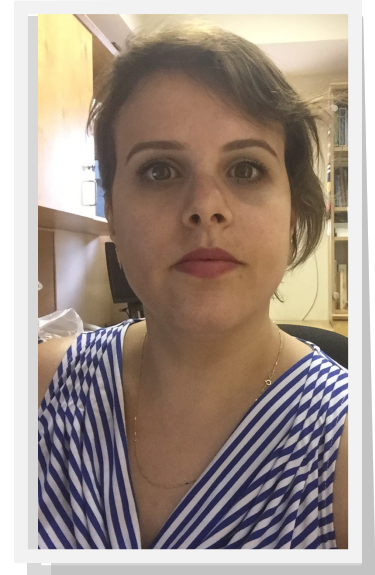

US Opposition to Breastfeeding Endangers Public Health

Health officials at the recent World Health Assembly (WHA) were stunned when the United States tried unsuccessfully to undermine a resolution to protect and promote breastfeeding. [The New York Times](#) revealed how an Ecuador-sponsored resolution seeking to help countries strengthen breastfeeding practices and restrict misleading marketing of breastmilk substitutes, expecting unanimous approval, was challenged by the United States, openly refuting decades' worth of evidence and research on infant and young child feeding.

In a move reminiscent of pressure from tobacco and sugar industries, US delegates sought to water down legislation that would empower countries to support mothers to breastfeed and to restrict the promotion of food products inappropriate for young children. When this failed, the American contingent resorted to threats of economic sanctions and withdrawal of military aid. In the face of intimidation from one of the world's most powerful countries, Ecuador had no choice but to protect its own national interest and withdraw the resolution. Other countries in need of this resolution were likewise hesitant to take the lead for fear of endangering existing ties with the US. Russia, unfazed by threats from the US, would eventually take up the cause for these embattled countries and support passage of the measure.

This recent opposition to breastfeeding by the US is nothing new – the breastmilk versus infant formula debate has persisted despite decades of research proving breastmilk as the best nutrition for babies. What is surprising, however, is the US' brazen attempt to thwart the resolution by resorting to tactics that are a clear overreaction, not unlike throwing the baby out with the bathwater. Threats of withdrawal of economic support and military aid are a staple of this current US administration – but over breastfeeding? Why would the US go to such lengths to derail a resolution in support of a major public health issue?

Conflicts of interest in public health should lead us to ask who stands to benefit the most from non-passage of this resolution. The major multinational milk companies such as Nestle, Danone, Mead Johnson, and Abbott have been quick to distance themselves from this issue, citing that they “strongly support breastfeeding,” and “have not and would never lobby any government to oppose breastfeeding policies anywhere in the world.” History though, says otherwise. There have been multiple documented reports of milk companies violating the International Code of Marketing of Breast Milk Substitutes by pushing for aggressive marketing of baby formula and food, providing gifts and samples to mothers and health workers, sponsorships of meetings and travel, even payments to health professionals as incentives to recommend formula over breastmilk. Not surprisingly, these tactics have been most successful not in the United States, but in poorer countries where breastfeeding safeguards are not as stringent (hence the need for the WHA resolution).

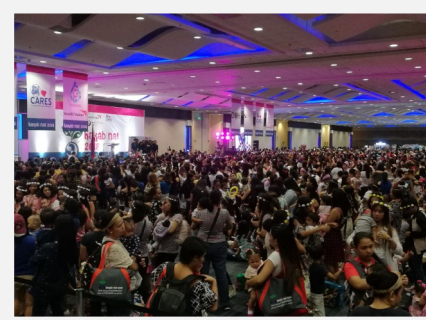
Israel is no stranger to this policy. As a response to growing numbers of reported violations, the Israel Pediatrics Association in 2017 issued a position paper stating that health professionals should encourage breastfeeding and avoid suggesting to parents stop it or promoting the use of baby formula. While there is a clear preference for breastfeeding in Israel especially in the early months, there has been a sudden drop in breastfeeding rates owing to shifts to formula feeding. The Philippines is likewise in a similar situation, where we have our own legislation Executive Order 51 or known as the Milk Code. However, exclusive breastfeeding rates remain below target, 1 in 3 Filipino children are stunted, and more than a million children are largely at risk for malnutrition. It is not uncommon to find doctors and health professionals being recruited by milk companies to give lectures to promote the use of infant formula. Just recently, it was discovered that milk companies were principal donors in a major government forum on nutrition – a clear violation of both local and international policy. Public health advocates decried this blatant lobbying with government as this exposed the massive influence of milk companies to dictate public health and nutrition issues.

In response to the growing disapproval of US actions at the WHA, US President Donald Trump has called the NY Times story as fake news, tweeting “The U.S. strongly supports breast feeding but we don’t believe women should be denied access to formula. Many women need this option because of malnutrition and poverty.”

Trump’s statement appears to be again misinformed as it is particularly during times of malnutrition and poverty that breastfeeding must be sustained. Propaganda is rife on how malnourished mothers and those living in poor conditions cannot breastfeed due to lack of milk or having milk of inadequate quality. This is far from the scientific truth that shows that malnourished mothers can breastfeed and their milk quality is still far superior to formula. The Philippines has had multiple experiences with disasters and emergencies where it has also been proven time and again that mothers can and should continue to breastfeed even in extreme conditions and should be provided a supportive environment to do so, rather than falling back on formula.

Support for breastfeeding does not mean denying formula for those who need it. Mothers should have a choice – but it should be an informed choice. When all is said and done, the decision to breastfeed should be made on fair grounds, free from the influence of milk companies and governments making threats of economic and political sanctions.

Andrew just recently completed work with UNICEF Philippines in scaling up the national program on Severe Acute Malnutrition. Currently he is on short-term engagement with Asian Development Bank for health emergency and rehabilitation, while being a full-time father to his newborn son and (together with his wife) advocate for health and nutrition issues such as breastfeeding.



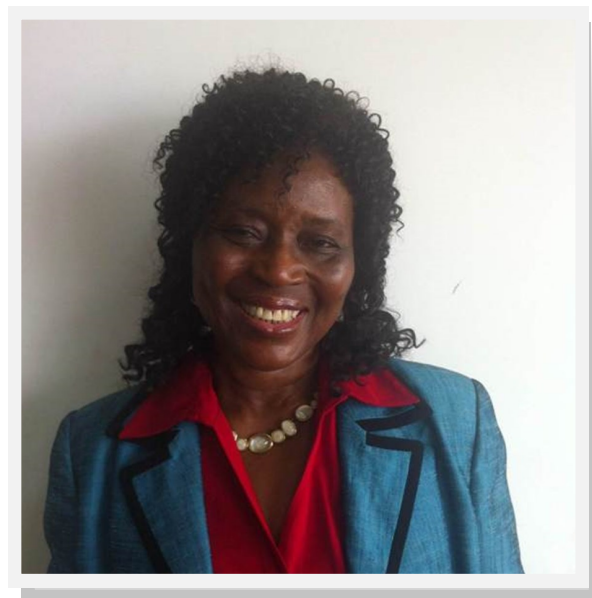
Highlighting an Alumna—Dr. Angela Benson (Liberia | IMPH 1990)

“Retired but not Tired” ([read about her pre-retirement career here](#))

Dr. Angela Benson is a Leader in global health, medical education, health policy, health sector management, program design, implementation, monitoring and evaluation. She has worked in the public health sector, the private health sector and the United Nations Organizations of UNICEF and WHO.

Dr. Benson coordinated health care services in several African Countries (Nigeria, Guinea, Ivory Coast, Ethiopia, Lesotho, Republic of Congo and Liberia) especially on Maternal –Child Health as a team leader and visionary. Following her IMPH training at the Hebrew University-Hadassah Braun School of Public Health in Israel, she worked as a National Health Officer for UNICEF during the civil conflicts in Liberia, then moved on to work for the WHO as an epidemiologist, then a Country Representative and retired as a WHO/AFRO Regional Adviser on Emergency & Humanitarian Action.

Since retirement in 2011, Dr. Benson has continued her tremendous service and contribution to Liberia’s Health Sector. As a manager and policy adviser to the central Ministry of Health (2012–2017), she provided oversight, technical, managerial and administrative support to government programs. She was the Foundation Manager for the Flagship Ministry of Health’s Fixed Amount Reimbursement Allowance (FARA) Program supported by USAID. With this Project, the Ministry of Health is reimbursed when they meet agreed upon, and independently verified targets in their National Health Plan . The Project is now being replicated in other African Countries. Dr. Benson was the second Secretary General to the newly established Post-graduate Medical Residency Program in Liberia – the Liberia College of Physicians and Surgeons (LCPS). She is currently an Examiner of the West African College of Physicians (WACP) with a focus on post-graduate qualifications for Membership and Fellowship in Community Medicine and its sub-specialties.



Dr. Benson co-founded the Global Health Innovations and Action Foundation (GHIA Foundation) - an International NGO with the aim of helping to reduce disease burden and mortality of women and children in low-income countries. The Foundation's mission is to ensure that women live healthier and longer lives by providing technical support to national governments in Sub-Saharan Africa to strengthen their health system and deliver positive results. She is also the co-founder and deputy CEO of Benson Hospital Inc. in Paynesville, Liberia.

Dr. Benson is a member of several national and international professional organizations including the Country Coordination Mechanism for HIV/AIDS, TB & Malaria in Ethiopia and Lesotho. She is a member of the AFREHealth Consortium, Public Health Association-Liberia, the Liberia Medical and Dental Association (LMDA), Fellow of the Liberia College of Physicians & Surgeons (FLCPS) and Fellow of the West African College of Physician (FWACP). She has co-authored and published medical articles and chapters on the Situation Analysis of the Health of Women and Children in Liberia. She was part of the Ministry of Health Consultants who wrote the comprehensive document: "The Investment Case: Building a Resilient Health System in Liberia, Post-Ebola". Dr. Benson's work has been exemplary at every stage making her an asset to her family, the community, the church and the Nation.

She is married to Dr. Jimi O. Benson and they have three adult children and several fostered children.

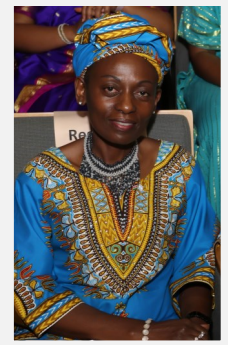

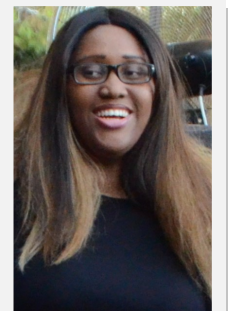
Alumni News

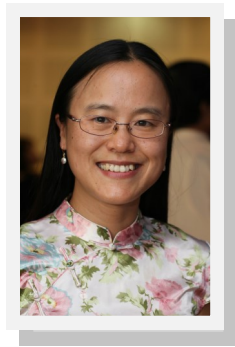
